ORDER

1. Vide paper read (1) above, University invited application for Continuation of Provisional Affiliation for the academic year 2024–25 from the colleges for the courses affiliated to the University.
2. In response to the same, the Principal Santhigiri Siddha Medical College Thiruvannathapuram, vide paper (2) above submitted their application with necessary documents and remitted required fee.
3. Subsequently, University conducted an inspection at the college to assess the facilities available for conducting BSMS course with 50 seats, and the inspection commission submitted its report vide paper read (3) above.
4. Vide paper read (4) above, the scrutiny committee verified the inspection report and

pointed out some deficiencies which were communicated to the college as per the paper read (5) above.

5. In response to the same, Principal submitted a compliance report vide paper read (6) above and the same was scrutinized by the scrutiny committee in detail and found satisfactory. Thereby, scrutiny committee recommended for granting Continuation of Provisional Affiliation to the college for the AY 2024-25 as per the paper read (7) above.

6. The recommendation of the scrutiny committee was placed in the 79th meeting of the Governing council for consideration, and vide decision read (8) above, Governing council resolved to grant Continuation of Provisional Affiliation to the college for conducting UG (BSMS) course with 50 seats for the academic year 2024-25, subject to the receipt of letter of permission from NCISM, Ministry of AYUSH.

7. Vide paper read (9) above, Medical Assessment and Rating Board for Indian System of Medicine, (NCISM) Ministry of AYUSH, Govt. of India has granted Conditional Permission to Santhigiri Siddha Medical College, Thiruvananthapuram, for intake capacity of 50 seats in UG (BSMS) for the academic session 2024-25, under section 28 of NCISM Act 2020.

8. As per the paper read (10) above, University had decided that an affidavit incorporating a clause to the effect that " if GST is imposed on the affiliation and other services by the authorities concerned, such GST and other dues including penalty if any will have to be borne by the affiliated institutions " and the same shall be submitted to the university by the affiliated institutions. The Principal, Santhigiri Siddha Medical College, Thiruvananthapuram has not submitted the affidavit regarding the levying of GST so far.

9. In the circumstances, orders are hereby issued granting **Conditional Continuation of Provisional Affiliation** to Santhigiri Siddha Medical College, Thiruvananthapuram having permission from Medical Assessment and Rating Board for Indian System of Medicine, NCISM, Ministry of AYUSH, Govt. of India for conducting BSMS course with intake of 50 seats in the Academic year 2024-25. **The conditional Continuation of Provisional Affiliation now granted will be confirmed only on submission of an affidavit by the college with respect to levying of GST in the prescribed format within 3 months of the date of this order.**

10. As per the clause 2(5)(ix) (16) of the amendment of the 1st statute on the matter of Affiliation of Colleges, ***if conditional affiliation is granted, conditions to be fulfilled and the time fixed for fulfilment of the conditions shall be specified in the order of the Governing Council granting affiliation. If the conditions are not fulfilled by the end of the period fixed, the affiliation shall cease automatically. If the conditions are fulfilled, the Governing council shall have the power to confirm the affiliation at the end of the period.***

11. The college shall strictly adhere to the following conditions detailed below:-

i) ***The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG courses in Siddha during 2024-25 vide letter read (9) above.***

ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.



iii) In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the college will be initiated.

iv) Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

v) The college should remit balance annual administration fee fixed for UG course for the academic year 2024-25, if applicable.

vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
