## ORDEF

1. As per notification read (1) above, the University invited application for the Continuation of Provisional Affiliation for the academic year 2023-24 from the colleges for the courses affiliated to the University. In response to the same, the Principal, Santhigiri Siddha Medical College, Thiruvananthapuram vide paper (2) above had submitted application for the continuation of provisional affiliation for conducting UG (BSMS) course with an annual intake of 50 seats for the academic year 2023-24 with necessary documents and remitted requisite fee.

2. As per clause II (4) of inspection ordinance, inspection for granting Continuation of Provisional Affiliation will be conducted every year till the first batch of the courses / enhanced seats in that institution is passed out. After that inspection will generally be conducted ones in two years provided the previous year's inspection report is satisfactory without any deficiencies. Since, Santhigiri Siddha Medical College, Thiruvananthapuram has satisfied the said criteria for granting Continuation of Provisional Affiliation without conducting inspection for the AY 2023-24, inspection was not conducted at the college for the AY 2022-23.

3. The 72nd meeting of the Governing Council vide decision read (3) above, resolved to grant Continuation of Provisional Affiliation to Santhigiri Siddha Medical College TVM for the AY

2023–24 without conducting inspection, subject to receipt of permission letter from National Commission for Indian System of Medicine, Ministry of AYUSH.

4. Now, vide paper read (4) above, the Medical Assessment and Rating Board, National Commission for Indian System of Medicine, Ministry of AYUSH, Government of India, New Delhi has granted conditional permission to Santhigiri Siddha Medical College, Thiruvananthapuram, Kerala for conducting UG (BSMS) course with 50 seats for the academic year 2023–2024.

5. In this circumstances, orders are hereby issued granting Continuation of Provisional Affiliation to Santhigiri Siddha Medical College, Thiruvananthapuram for conducting the BSMS course with an annual intake of 50 (Fifty) seats for the academic year 2023–24 subject to the conditions detailed below:

i) The college shall comply the conditions prescribed by the Ministry of AYUSH, Govt. of India in the permission order granting permission to the college to conduct UG (BSMS) course during the AY 2023–24 vide letter read (4) above.

ii) Selection, admission and collection of fee shall be made only on the basis of rules and regulations of the University / Govt. of Kerala and on the basis of direction issued by th University from time to time, failing which the affiliation will be cancelled.

iii) In light of the direction of the Supreme Court of India in Writ petition (C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

iv) Affiliation granted is strictly provisional and only for the Academic year 2023–24. The college has to apply for continuation of Provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of Approval from the apex bodies concerned.

v) The college should remit annual administration fee fixed for UG course for the academic year 2023–24, if applicable.

vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
