### ORDER

1. Vide paper read (1) above, University invited application for Continuation of Provisional Affiliation for the academic year 2025–26 from the colleges for the courses affiliated to the University.
2. In response to the same, the Principal Santhigiri Siddha Medical College Thiruvananthapuram, vide paper (2) above submitted their application with necessary documents and remitted required fee.
3. Subsequently, University carried out an inspection at the college to assess the facilities available for conducting BSMS course with 50 seats, and the inspection commission submitted its report vide paper read (3) above.



4. The scrutiny committee in its meeting dated 22.04.2025 verified the inspection report and pointed out some deficiencies which were communicated to the college as per the paper read (5) above.
5. Vide paper read (6) above, the Principal submitted a compliance reports, and the same were scrutinized by the scrutiny committee in its meeting dated 22.05.2025 and found satisfactory. Thereby, the committee recommended for granting Continuation of Provisional Affiliation to the college for the AY 2025-26.
6. 84<sup>th</sup> meeting of the Governing Council and vide decision read (7) above, resolved to grant Continuation of Provisional Affiliation to the college for conducting UG – BSMS course with 50 seats for the academic year 2025-26, subject to receipt of Letter of Permission from National Commission for Indian System of Medicine, Ministry of AYUSH, Govt. of India.
7. Vide paper read (8) above, Medical Assessment and Rating Board for Indian System of Medicine, (NCISM) Ministry of AYUSH, Govt. of India has granted extended Permission in UG (BSMS) course with intake capacity of 50 seats to Santhigiri Siddha Medical College, Thiruvananthapuram, for the academic session 2025-26, in accordance with regulation 60 (1) (a) of minimum essential standards, Assessment and Rating for Undergraduate Siddha Colleges and Attached Teaching Hospitals Regulations, 2024.
8. Accordingly, orders are hereby issued granting Continuation of Provisional Affiliation to Santhigiri Siddha Medical College, Thiruvananthapuram for conducting **UG (BSMS) course with 50 seats** for the academic year 2025-26.

**1. The college shall strictly adhere to the following conditions detailed below :-**

- The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting extended permission to the college for conducting UG courses in Siddha during 2025-26 vide letter read (8) above.
- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the college will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2025-26. The college has to apply for Continuation of Provisional Affiliation for the ensuing years, remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- The college should remit balance annual administration fee fixed for UG course for the academic year 2025-26, if applicable.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
